Ganacsiyadahan waxay u isticmaali doonaan dalabka deeqda dhaqaalaha ACCD inay ku dalbadaan lacagahaas.

Codsigu waa inuu qaataa ilaa 10-15 daqiiqadood inuu dhammaystiro haddii aad diyaar u tahay qalabkaaga oo dhan Deeqaha waxaa lagu bixin doonaa marka ugu horeysa, oo marka ugu horeysa la adeegto, sidaa darteed haysashada waxkastoo aad u baahan tahay si aad u dalbato diyaar u ah marka arjiga toos loo diro aad ayey muhiim u tahay.

Deeqaha Soo-kabashada Dhaqaalaha ee Vermont ayaa la soo saaray si ay uga caawiso bixinta taageerada dhaqaalaha ganacsigaaga, taasoo saameyn ku yeelatay hoos udhaca baahida macaamiisha sababtoo ah xaalada degdega ah ee caafimaadka dadweynaha ee COVID-19. Lacagaha ayaa loo isticmaali karaa labadaba si loogu bixiyo kharashaadka lagama maarmaanka ah ee shirkaddaadu ku soo gasho iyo kharashaadka tooska ah ee laxiriira jawaabtaada ganacsiga ee feyraska COVID-19. Nidaamka Kala-soocidda Wershada Waqooyiga Ameerika (NAICS) waxaa adeegsadaa Mareykanka, Kanada, iyo Mexico si loogu kala saaro meheradaha wax soosaarka. Ganacsi kastaa wuxuu go'aaminayaa lambarkiisa lambar lix-nambar ee NAICS lambarkiisa iyadoo lagu saleynayo waxqabadka badan ee ganacsiga. Markaad xareysid canshuurta dakhliga ee dowladda dhexe, waxaad bixisaa "business code" oo

ku saleysan lambarka NAICS macluumaadka ku qoran diiwaangelinta canshuurta ganacsigaaga waxaa ku jira jadwal lambaradaas. Hay'adaha aan macaash doonka ahayn waxaa laga yaabaa inaysan laheyn baaqa sirta ah ku habboon NAICS waana laga dhaafay shuruudahan.
